# EASY TO ENJOY THE PLAYOFFS SWEEPSTAKES OFFICIAL RULES

Entry Period 2 begins at the start of each NFC Divisional Game and each AFC Divisional Game scheduled to occur on January 20, 2024 and January 21, 2024 (each a "Divisional Game") and ends at the conclusion of each Divisional Game scheduled to occur on January 20, 2024 and January 21, 2024 (the "Divisional Round"). The date/time of each Divisional Game will be announced by the NFL following the conclusion of the final game of the Wild Card Round and is subject to change. There are four (4) Divisional Games scheduled to occur during Entry Period 2.

# Entry Period 3 (Championship Round):

Entry Period 3 begins at the start of the NFC Conference Championship Game and the AFC Conference Championship Game scheduled to occur on January 28, 2024 (each a "Conference Championship Game") and ends at the conclusion of each Conference Championship Game scheduled to occur on January 28, 2024 (the "Championship Round"). The date/time of each Conference Championship Game will be announced by the NFL following the conclusion of the final game of the Divisional Round and is subject to change. There are two (2) Championship Games scheduled to occur during Entry Period 3.

# Entry Period 4 (Super Bowl LVIII):

Entry Period 4 begins at the start of Super Bowl LVIII scheduled to occur on February 11, 2024 ("Game") and ends at the conclusion of the Game.

#### Entry Prize Details:

Entry Prize will be fulfilled by a one-time Venmo payment made directly to winner's Venmo account. # 5. GRAND PRIZE SWEEPSTAKES DRAWING:
